In consideration of the mutual promises set forth below, and intending to be legally bound, the parties agree as follows:

Trainee shall attend the Primary Permanent Makeup Training Program (“*Program*”) offered and conducted by Beau Institute at its Cherry Hill, NJ location (or by remote access) from \_\_\_/\_\_\_/\_\_\_ through \_\_\_/\_\_\_/\_\_\_ . The selected Program dates are non-transferrable by Trainee without the approval of Beau Institute. Trainee may reschedule, however, within 18 months in the event that the Program is cancelled due to a *force majeure* event, such as civil unrest, terrorism, war, government order, epidemic/pandemic, power outages, severe weather, flood, fire or other casualty, or any other occurrences outside the parties’ reasonable control.

The Program will cover permanent eyebrow, eyeliner and lip color application. The Program does not include microblading, scar camouflage, areola re-pigmentation or any other paramedical procedures.

The tuition cost of the Program is \$5,500.00. A \$1,000 ***non-refundable*** deposit is required to register for the Program. The balance shall be due and payable prior to commencement of the Program. No refund of tuition cost paid is available upon cancellation by Trainee for any reason or by Beau Institute due to an event of force majeure.

Upon registration, Trainee will be sent the Bloodborne Pathogens information that is required to be completed online prior to commencement of the Program. Once the deposit is received, a comprehensive textbook will be sent to Trainee. Trainee must bring the textbook, along with a notepad, pen/pencil and camera, each day of class. It is Trainee’s responsibility to document procedures using his or her own camera. Beau Institute will not provide photographs taken during training.

Trainee further acknowledges and agrees that:

- Trainee will not receive a certificate of completion until tuition is paid in full.
- It is Trainee’s responsibility to investigate all licensing, apprenticeship, insurance and other state and local requirements for the practice of permanent cosmetics in the area in which he or she intends to work.
- The Program is proprietary to Beau Institute and provided to Trainee solely for his or her participation and education. Trainee shall not record, reproduce, post on the Internet or otherwise share or publish the Program or any recording or reproduction thereof in any manner without the consent of Beau Institute.
- Trainee hereby releases Beau Institute and its members, instructors, employees and other agents (collectively, the “*Beau Parties*”) from any and all liability for injury, death or other damage suffered by Trainee or any individual upon which Trainee performs any permanent cosmetic procedure, at any time during or after the completion of the Program; and Trainee shall indemnify, defend and hold harmless the Beau Parties from any claim or lawsuit arising out of Trainee’s participation in the Program or performance of such procedures.

This Agreement shall be interpreted, governed and enforced in accordance with the laws of the State of New Jersey. The parties submit to the jurisdiction of the federal and state courts located within Camden County, New Jersey, and WAIVE ANY RIGHT TO A TRIAL BY JURY, in any suit, action or proceeding under this Agreement.
